## **Section 2: Explanatory Information**

- 1. Urgent Market Messages (UMMs) in relation to the wind assets listed in Section 1 (Standing Data) of this fact sheet will be published simultaneously to the ScottishPower REMIT website (<a href="http://www.scottishpower.com/pages/scottishpower\_remit\_home\_page.asp">http://www.scottishpower\_remit\_home\_page.asp</a>) and the REMIT pages of the Balancing Mechanism Reporting Service (BMRS) operated by Elexon (<a href="https://www2.bmreports.com/bmrs/?q=remit">https://www2.bmreports.com/bmrs/?q=remit</a>). The information on both websites should be identical but in the event of any discrepancy please contact us through your usual channel. UMMs in relation to the Gas Storage Assets are published on the ScottishPower REMIT website and National Grid website (https://www.remit.gb.net/).
- 2. We aim to publish information in relation to new or amended outages and restrictions as close to real time as possible and at the latest within 1 hour
- 3. We only publish information in relation to outages/restrictions for wind assets with a generating capacity greater than or equal to 100MW.
- 4. We publish information in respect of all changes in wind output availability of greater than or equal to 100MW. We will also publish information in respect of changes in wind output availability of less than 100MW if we believe that it has the potential to significantly affect wholesale energy prices.
- 5. The event start and end time that are published for each UMM are rounded to the start or end of the half hour periods, except for amendments or cancellations made to a current ongoing planned outage, which will show the actual end time.
- 6. We publish information in respect of all outages and restrictions at the Hatfield Moor gas storage facility (no threshold applied).
- 7. The gas flow information in relation to Hatfield Moor is published daily at the end of each gas day.



- 8. The information in relation to the UMMs will be available in the Archive pages of the website for a minimum of 5 years from first publication.
